# Chapter 8

*Police officer's report:* May 1st, 1884, Officer Watkins: A lot of people were walking on the new bridge. The piece of engineering fascinated them and most of them laughed, talked, looked around and were in a good mood. The weather was fine which attracted even more people to the bridge. I don't remember exactly what happened but suddenly my girlfriend screamed "Help!" and fell over the railing into the Hudson River. I can't tell you how shocked I was. At first I didn't know what to do, then I realized that there was no police around, only masses of people panicking. So I jumped into the water to save my girlfriend. The water was very cold but we made it to the shore.
